Mr. Emery called the meeting to order. The Additions/Deletions were provided to attendees.

Mr. Emery stated the purpose of this meeting is to offer the public an opportunity to express their opinions on pending permit applications listed on today's agenda prior to decisions being made on those permits. The intent of this meeting is to gather information from the public, not for the staff to discuss or debate the merits of the application. No decision on any pending permit applications will be made at this meeting.

The District uses its rules to evaluate an application to determine if the application should be issued or denied. Only those comments that are pertinent to the District's authority to evaluate a permit application will be considered by District staff during the review of the application.

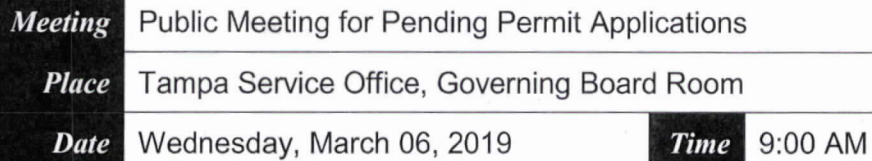
Mr. Emery reviewed the scope of the District's permitting process, which provides reasonable assurance that a construction activity does not harm the environment. A District permit does not address the appropriateness of an activity, or whether or not that activity should occur. Those types of land use decisions are made by local governments, who have their own mechanisms for public input.
