# Northern Tampa Bay Phase II Local Technical Peer Review Group (LTPRG) SWFWMD Tampa Service Office, Hwy 301N, Tampa

### Meeting 32 August 9, 2006 - 9:30AM

## **Summary**

Doug Leeper provided an update on the status of minimum flows and levels development for priority District lakes. He noted that with the exception of Lake Wimauma, it is anticipated that minimum levels for all 2005 priority lakes will be presented to the Governing Board for adoption this fall. He explained that adoption of minimum levels for Lake Wimauma will be delayed pending completion of a planned District and the Hillsborough County Environmental Protection Commission project designed to examine factors affecting the lake's water levels. Mr. Leeper also noted that data collection and analyses for the 2006 priority lakes is ongoing. Finally, he indicated that District-funded studies involving a survey of lake-user perceptions of lake values as a function of water levels and an evaluation of the maximum depth of macrophyte colonization and water transparency have been completed, and final project reports will be made available at the next LTPRG meeting.

Dan Schmutz gave a presentation on the recently completed "Five Year Wetland Assessment:" in the northern Tampa Bay area. Berryman & Henigar led a team of consultants that performed the assessment for the SWFWMD, as a follow-up to a similar assessment performed in the 1997/1998 period. The project consisted of creating a GIS-based database for the original data, and then performing a similar assessment for the 2004/2005 period. Mr. Schmutz's presentation is found on the NTB II website. The study found some changes in wetland health between the two periods (in both directions, but conclusions on cause and effect will become more accurate as more such data is collected.

Marty Kelly gave the group a presentation on the status of the development of minimum flows in the Upper Hillsborough River watershed. Dr. Kelly reported that District staff

has not determined the final values to be proposed to the District's Governing Board, he was able to outline the District's approach, and some of the findings. Dr. Kelly's presentation is also found on the NTB II website.
