### Services/Commodity Description:

Manufactures and/or supplies equipment/parts, provides installation, and/or installation oversight services for a pneumatically actuated spillway gate system compatible with an existing Obermeyer-Hydro, Inc. pneumatic spillway gate system. The existing system is made up of a row of bottom hinged steel gate panels supported on their downstream side by inflatable air bladders with reinforced rubber webs between each section, which allows the system to be more precisely adjusted at user-selected set points and does not use intermediate piers.
