Please note the following change to Paragraph 1.17, **BID TABULATION AND NOTICE OF AWARD** (pg. 6 of 61), of the above referenced solicitation:

**1.17 BID TABULATION AND NOTICE OF AWARD.**

Bid recaps and bid tabulations will not be provided by telephone or fax. Pursuant to Section 119.071(1) (b), F.S., all bids submitted will be subject to review as public records thirty (30) days from bid opening or at the time the District provides notice of its intended decision if such decision is reached prior to the expiration of the thirty day period.

Please note the following change to Paragraph 2.2, **TERM** (pg. 9 of 61), of the above referenced solicitation:

**2.2 TERM.**

~~We would like the new paragraph to state~~ "All work except for quarterly maintenance of all enhanced/restored/created wetlands and upland habitats shall be substantially completed within 90 calendar days from issuance of the Notice to Proceed (NTP) and final completion within ~~30~~ 45 calendar days thereafter.

Please note the following change to add Paragraph 2.40, POTENTIAL FERAL HOG DAMAGE (pg. 20 of 61), of the above referenced solicitation:

**2.40 POTENTIAL FERAL HOG DAMAGE.**

The District recognizes/acknowledges the presence of feral hogs on the Myakka State Forest Water Quality Bank Stabilization Project. There is a possibility that hogs may cause damage to the Project site. The Contractor will notify the District of hog damage to the Project site within 24 hours of observance. The District will be responsible for paying the Contractor to repair hog damage, both to the ground surface and/or plant materials. During the maintenance/monitoring period, the Contractor will document hog damage to the site by taking photographs of the damage and submitting the photos to the District's PM for inspection. The District will determine, in its sole discretion, whether the damage to the Project site was caused by hogs, and if so, if the damage warrants corrective action. The Contractor will be paid for the additional earthwork or additional plant installation using additional funds.
