Please note the following change to Section 3.2, Work Objectives of the above referenced solicitation:

3.2.1 Removal of all non-native plant species from the Project Site to be implemented over a minimum of two consecutive years during the Site Preparation phase prior to planting. <u>Large</u> trees/shrubs may be left standing if they meet the requirements provided in Section 3.3.1.1.13.

Please note the following changes to Section 3.3.1, Site Preparation of the above referenced solicitation:

3.3.1.1.11 The Contractor shall be required to herbicide any exotics found on the 0.5 acres in the northeast portion of the Project site as indicated in Figure 4, Restoration Sectors. This area will ultimately be used as a parking area and may be reconfigured to avoid permanent impacts to existing gopher tortoise burrows. The Project Manager will delineate the final boundaries on the ground prior to commencement of the Project, but the area acreage shall remain the same. The Contractor will be expected to maintain an annual variety of non-invasive cover crop such as millet on this portion of the Project site.

3.3.1.1.12 <u>The Contractor shall not perform restoration services on the 0.36 acres Cemetery as indicated in Figure 4, Restoration Sectors.</u>

3.3.1.1.13 <u>Large trees/shrubs greater than 4 inches in diameter at breast height</u> (dbh), may be treated and left standing, depending on treatment method and impact on successful native ground cover restoration.

Please note the following change to Section 5.1, Review of Proposals of the above referenced solicitation:

REVIEW OF PROPOSALS. Timely submitted responsive proposals will be evaluated by an Evaluation Committee consisting of four (4) or more representatives of the District. Each representative will score each proposal using the criteria described in Section 5.2, Evaluation Method and Criteria.

The Evaluation Committee will meet at a public meeting to be held at Tampa Service Office, Building 1, Governing Board Room, 7601 Highway 301 North, Tampa, Florida 33637-6759 District Headquarters Building 4, Room 251, 2379 Broad Street, Brooksville, Florida 34604-6899. At this meeting, the Committee may select a short list of Respondents to provide oral presentations to the Committee, or the Committee may finalize the rankings of the proposals.

Any person deciding to appeal any decision made by the District with respect to any matter considered at this meeting, will need a record of the proceedings, and that, for such purpose, may need to ensure that a verbatim record of the proceeding is made, which record includes the testimony and evidence upon which the appeal is to be based.
