This letter will serve as authorization for Southwest Florida Water Management District, its officers, employees, agents, and contractors to enter the property described above for the temporary construction staging area for the maintenance and repair of the water holdback structure in the Big Grant Canal, see attached Exhibit "A". This authorization does not waive the authority and/or jurisdiction of any governmental entity, nor does it disclaim any title interest that the Board of Trustees of the Internal Improvement Trust Fund of the State of Florida (Board of Trustees) may have in this property. This authorization is effective as of the date of this letter and is valid for one year.

Southwest Florida Water Management District agrees to indemnify, protect, defend, save and hold harmless Board of Trustees and the State of Florida, its officers, agents and employees from any and all damages, claims, costs, expense, including attorney's fees, demands, lawsuits, causes of action or liability of any kind or nature arising out of all personal injury or damages attributable to the acts or omissions of Southwest Florida Water Management District and its agents, employees or independent contractors. Southwest Florida Water Management District shall contact GRANTOR regarding the legal action deemed appropriate to remedy such damage or claims. The Southwest Florida Water Management District shall maintain a program of insurance covering its liabilities as prescribed by Section 768.28, F.S. Nothing herein shall be construed as a waiver of sovereign immunity enjoyed by any party hereto, as provided in Section 768.28, Florida Statutes, as amended from time to time, or any other law providing limitations on claims. In the event Southwest Florida Water Management District subcontracts any part or all of the work performed in the property described above, the Southwest Florida Water Management District shall require each and every subcontractor to identify the GRANTOR

as an additional insured on all insurance policies required by the Southwest Florida Water Management District. Any contract awarded by the Southwest Florida Water Management District for work in the property described above shall include a provision whereby the Southwest Florida Water Management District's subcontractor agrees to indemnify, pay on behalf, and hold the GRANTOR harmless for all injuries and damages arising in connection with the Southwest Florida Water Management District's subcontract.




