All Potential Respondents RFP 1908 Districtwide Seagrass Mapping Rachelle Jones, Senior Procurement Specialist SUBJECT: Response to Questions

QUESTION: Section 3.1 of the RFP states that the District has a preference for push-broom multi-spectral sensors for this project but that, as technology advances, other sensor-types may be acceptable. Would the District consider frame sensors as an alternative?

ANSWER: The District will consider all sensors that are capable of producing the deliverable products according to the specifications in the RFP. The push-broom multi-spectral sensor is a preference, not a requirement.

QUESTION: Would the District evaluate a proposal with push-broom multispectral sensors as technically superior to a proposal incorporating frame sensors?

ANSWER: The District will evaluate proposals in accordance with the evaluation procedures posted in the solicitation documents.

QUESTION: For capturing imagery and video under Section 3 of the scope of work, do the Exhibit "B" Full Motion Video Specifications as well as the guidelines and specifications for the operation of unmanned aircraft systems (UAS) in Exhibit "C" apply?

ANSWER: Exhibit "B" Full Motion Video Specifications and Exhibit "C" Guidelines and Specifications for the Operation of Unmanned Aircraft Systems (UAS) apply only when the full motion video (FMV) or imagery is being used as part of a mapping mission (Section 1 of this RFP). If full motion video is used in an underwater configuration to collect information to support ground-truth or field verification missions (Section 3 of this RFP), then the District requires HD video and navigational grade GPS for the purpose of ingesting FMV into an ESRI ArcGIS environment. If UAS imagery is collected to support a ground-truth or field verification mission (Section 3 of this RFP), then the District expects the respondent for follow FAA guidelines referenced in Exhibit "C".
