





Murphy QUESTION: Is burning permitted? Polk **Rebecca Smith** Hillsborough, Pinellas ANSWER: In consideration that much of the construction activities involve the Seth Weightman Pasco TECO right-of-way and burning is not allowed on TECO fee-owned properties and/or easements, and in consideration that the Brian J. Armstrong, P.G. **Executive Director** PROJECT area lies adjacent to multi-family residential facilities (condominiums and apartments) as well as low density single-family residential developed areas and businesses, burning will not be allowed with PROJECT construction. Section 02110 "CLEARING AND GRUBBING", Part 3.08.B. of the Technical Specifications regarding burning debris does not apply because burning is not permitted. Instead, vegetation and trees that have been cut or uprooted resulting from site clearing and/or cut vegetation resulting from nuisance non-native vegetation selective or hand trimming should be removed from the PROJECT area and disposed of at an approved upland facility in accordance with all local, state and federal regulations. QUESTION: Who will be the District's Representative for the project? Will it be the District or is there a named CEI firm? The District's Project Manager administering the construction ANSWER: contract is Janie Hagberg, P.E. The design firm, Ardurra Group Inc., will provide Construction Engineering and Inspection (CEI) services during construction. 
