2. The question and answer period has been extended in accordance with Section 1.6, Questions of this RFB, due to the change in bid opening date.
3. Please note the following change to RFB 23-4249:

An Additional non-mandatory site visit for contractors and subcontractors will occur on Friday, October 13, 2023, from 10:00 a.m. to 12:00 p.m. local time. District staff will be on site to allow access but will not answer questions. Contractors and subcontractors may attend at any time during this time period but must exit the District structure property by 12:00 p.m. local time.

1. **Question:** **Is it possible for a company that has not worked on Cathodic Protection with the client to present an offer in this tender?**

Answer: Bidders are not required to have previously worked with the District to submit a bid. Please refer to the solicitation documents for contractor and subcontractor qualifications and requirements.

2. **Question:** **Do you only accept submissions electronically through DemandStar?**

Answer: Please refer to Section 1.7, Bid Receipt and Opening, of the solicitation document. Yes, the District only receives responses electronically through DemandStar at www.demandstar.com.

3. **Question:** **Are we to provide a copy of the bid bond with submission and mail the original to you within 3 days?**

Answer: Please refer to Section 2.19, Bonding, Subsection 2.19.1.1, Bid Bond, of the solicitation document. Electronic submittals require a copy of the bid security (forfeiture bid bond, cashier's check, or certified check) to accompany the submission. The original bid security will be delivered within three business days after the bid opening or postmarked on or before the bid opening date.

4. **Question:** **Will an additional site visit be provided to look at the Project site?**

Answer: Please refer to Clarification 3 of this Addendum. The District will hold an additional non-mandatory site visit for contractors and subcontractors on Friday, October 13, 2023 from 10:00 a.m. to 12:00 p.m. local time. Contractors and subcontractors may attend at any time during this time period but must exit the District structure property by 12:00 p.m. local time. District staff will not answer questions at this site visit.
