I. CLARIFICATIONS:

1. The COVER SHEET has been amended as follows to extend the Bid Due Date and Opening:

BID DUE DATE AND OPENING: JANUARY 20 13, 2026 AT 2:00 P.M. LOCAL TIME

2. Subsection 2.2.1 is hereby amended as follows:

2.2.1 A Notice to Proceed (NTP) shall be issued by the District on or before February 23 16, 2026. Provided the District issues the NTP by this date, the Contractor shall commence Project work within ten business days and reach substantial completion on or before July 24, 2026, with final completion being reached on or before September 25, 2026. If the NTP is not issued by February 23 16, 2026, the District will have the option to extend the completion dates or to postpone construction to after the 2026 Rainy Season (defined as typically June 1 - September 30 and dependent on atmospheric, precipitation, and water level conditions).

3. Attachment 7, Sample Agreement, Subsection 3.1 is hereby amended as follows:

3.1 A Notice to Proceed (NTP) shall be issued by the District on or before February 23 16, 2026. Provided the District issues the NTP by this date, the Contractor shall commence Project work within ten business days and reach substantial completion on or before July 24, 2026, with final completion being reached on or before September 25, 2026. If the NTP is not issued by February 23 16, 2026, the District will have the option to extend the completion dates or to postpone construction to after the 2026 Rainy Season (defined as typically June 1 - September 30 and dependent on atmospheric, precipitation, and water level conditions).
