I. CLARIFICATIONS:

II. QUESTIONS AND ANSWERS:

1. **Question:** **Can you ask the Engineer to unlock the drawings so we can conduct an on-screen quantity survey with our Revu Bluebeam software?**

Answer: Yes. Please refer to Clarification #2 of this Addendum.

2. **Question:** **Could you add an Allowance for: Lead Abatement of the bridge?**

Answer: Line item 12 is inclusive of “Off-site disposal of existing bridge” and “Lead paint disposal.” Please refer to Section 01020, Measurement and Payment, Subsection 2.12, New Bridge Complete, subsection B, Payment, bullets 2 and 3 on page 01020-7 of Figure 2 - RFB 25-4832 Technical Specifications.

3. **Question:** **Will the District consider making a firm statement that it is delaying the NTP until after the 2026 rainy season?**

Answer: No. Please refer to section 2.2, Term., Attachment 7, Sample Agreement, section 3, Effective Date; Term, and Addendum 2, Clarifications #2 and #3.

4. **Question:** **Please confirm that a bypass around the structure is not required on this project.**

Answer: Bypass pumping around the structure will not be required on this Project. Please refer to Clarification #3 of this Addendum.
